Dear Participant:

This Participant Notice will advise you of certain material modifications that the Board of Trustees has made to the Central Texas Health and Benefit Trust Fund. This information is VERY IMPORTANT to you and your dependents. Please take the time to read it carefully.

### **New MDLIVE Virtual Visits Starting July 1, 2021**

The Board of Trustees is pleased to introduce a new health care service called **MDLIVE** that offers you the ability to talk to an in-network health care provider anytime and anywhere. Effective July 1, 2021, you can consult with a health care provider, or mental health therapist, by phone or videoconference through MDLIVE, 24 hours a day, seven days a week.

### There is no cost to you to use MDLIVE.

MDLIVE is a telemedicine program that delivers quality healthcare by using Board-certified doctors and Certified therapists who can diagnose and treat many common non-emergency illnesses and injuries. The benefits of using MDLIVE are as follows:

- Convenient 24/7/365 nationwide access to Board-certified doctors from your home, office, or on the road
- Consults with doctors via phone or video-conferencing; doctor makes diagnosis for many common medical conditions and recommends treatment
- Doctor sends in prescription to your preferred local pharmacy, when appropriate
- Participants can speak to a behavioral health specialist from the comfort and privacy of your own home
- Participants can avoid unnecessary visits to the ER, or long waits for an appointment at the doctor's office
- No out-of-pocket cost

MDLIVE can be used for the following:

- Colds, sore throats, flu, allegories, infections, upset stomach, pink eye, or rashes
- If you are considering the ER or urgent care for a non-emergency issue
- For short-term prescriptions or re-fills, when appropriate
- Anxiety, depression, or stress management

The MDLIVE program is separate from your Plan's benefit that allows scheduled telephone and virtual visits with your own medical provider, which are subject to the normal deductible, copayment, and coinsurance provisions of your Plan, on the same basis as a face-to-face visit would be.

Watch your mail for new ID cards from Blue Cross & Blue Shield of Illinois coming soon. Your new ID card will include information on how to access MDLIVE. Be sure to use this new ID card after July 1, 2021.

#### In-Network Providers vs Out-of-Network Providers




